RULES AND REGULATIONS

- CHECK-IN TIME IS AFTER 4 P.M. AND CHECK-OUT IS 11 A.M.**
- This is a **NON SMOKING** unit.
- We will not rent to vacationing students or singles under 25 years of age unless accompanied by an adult guardian or parent.
- DAMAGE/SECURITY DEPOSIT-** Reservation deposit of \$500 is required. This must be received immediately upon booking the reservation. The deposit automatically converts to a security/damage deposit upon arrival. The deposit is NOT applied toward rent; however, it is fully refundable within (7) days of departure, provided the following provisions are met.
 - No damage is done to unit or its contents, beyond normal wear and tear.
 - No charges are incurred due to contraband, pets or collection of rents or services rendered during the stay.
 - All debris, rubbish and discards are placed in dumpster, and soiled dishes are placed in the dishwasher/sink.
 - All keys are left on the kitchen table and unit is left locked.
 - All charges accrued during the stay are paid prior to departure.
 - No linens are lost or damaged.
 - No Early check -in or late check -out unless prior arrangement with management

NOTE: In 99.9% of all cases the security deposit will be refunded, and of course there is No charge for normal wear and tear of the house. However, here are some common reasons for deductions from the Damage/Security deposit:

- * Excessive garbage on departure
- * Broken or missing items from Inventory
- * Spills/stains on stove
- * Blocked toilets due to excessive paper and sanitary items etc
- * Non removable stains on sheets and towels-blood/bleach/permanent marker, etc.
- * Carpet and furniture spills that require professional treatment
- * Relocation of furniture/bedding to original position
- * Lost of Keys and/or front lock boxes, garage remote control

5. **PAYMENT** – Full payment is required 10 days before arrival. Please make payments in the form of traveler's checks, bank money orders, cashier's checks or personal checks. Please send all payments payable to: **AMIGOS RENTAL LLC**

6. **CANCELLATIONS** - A forty-five (45) day notice is required for cancellation. Cancellations that are made more than forty-five (45) days prior to the arrival date will incur no penalty. Cancellations or changes that result in a shortened stay, that are made within forty-five (45) days of the arrival date, forfeit the full advance payment and Security/Reservation deposit. Cancellation or early departure does not warrant any refund of rent or deposit.

7. **MONTHLY RESERVATION CANCELLATIONS** - Monthly renters must cancel ninety (90) days prior to check-in. Monthly renters who make a change that results in a shortened stay must be made at least sixty (60) days prior to check-in.

8. **MAXIMUM OCCUPANCY**- The maximum number of guests is limited to twelve (12) persons. An additional charge of \$150.00 per person per night for guests in addition to twelve (12) will be assessed.

9. **MINIMUM STAYS**-Weekends require a TWO (2) Night Minimum Stay. Holidays require a THREE (3) Night Stay.

10. **INCLUSIVE FEES** - Rates include a one-time linen-towel setup. Amenity fees are included in the rental rate.

11. **NO DAILY MAID SERVICE** - While linens and bath towels are included in the unit, daily maid service is not included in the rental rate however is available at an additional rate. We do not permit towels or linens to be taken from the unit.

12. **RATE CHANGES** - Rates subject to change without notice.

13. **FALSIFIED RESERVATIONS**- Any reservation obtained under false pretense will be subject to forfeiture of advance payment, deposit and or rental money, and the party will not be permitted to check in.

14. **WRITTEN EXCEPTIONS** - Any exceptions to the above mentioned policies must be approved in writing in advance.

15. **Parking** - Parking is limited to three (3) vehicles. Vehicles are to be parked in designated parking areas only. Parking on the road is not permitted. Any illegally parked cars are subject to towing; applicable fines/towing fees and is the sole responsibility of the vehicle owner.

16. **Hot Tubs - No children** under the age of 12 are not permitted in hot tubs at any time. When using the hot tub, remember there is certain health risk associated with this facility. Use at your own risk. Our housekeepers drain, sanitize, refill and replenish chemicals in all tubs prior to your arrival; therefore, it may not be warm till later that evening. Hot tub covers are for insulation purposes and are not designed to support a person or persons. **DO NOT STAND ON THE HOT TUB COVERS**, they will break and you may be charged replacement. Remember when not using the hot tub, leave cover on so hot tub will stay warm.

17. **STORM POLICY/ROAD CONDITIONS** - No refunds will be given for storms. We do not refund due to road conditions.

18. **PRIVATE OWNER** - Our Property is privately owned; the owners are not responsible for any accidents, injuries or illness that occurs while on the premises or its facilities. The Homeowners are not responsible for the loss of personal belongings or valuables of the guest. By accepting this reservation, it is agreed that all guests are expressly assuming the risk of any harm arising from their use of the premises or others whom they invite to use the premise.
